2. The Committee shall make a comprehensive study induce consultation with the Secretaries to Government and HoDs of the departments and submit its report, inter-alia, covering the following aspects,

- a. The Secretariat Department / Head of the Department / Corporations / PSUs / Local Bodies / Societies / Universities / Institutions – wise number of regular posts sanctioned, working and vacant and the need for their continuation, new sanctions, or modifications *vis a vis the* present priorities, needs and requirements.
- b. A similar study in respect of all categories of temporary services permitted by the Government, including contractual and outsourced services
- c. Any other issues relevant in this regard.

3. The Finance Department will provide the necessary information to the Committee and also assist the Committee in its above exercise.

4. The Committee may obtain such further information as may be required, from the Finance and the concerned administrative departments for the purpose of the above exercise.
5. The Committee may submit its report within a period of 60 days.
